

WHEREAS, the initial term of Magistrate Judge Jonathan R. Quan Jr. ("Magistrate Judge Quan") is set to expire on September 4, 2022; and

WHEREAS, pursuant to 7 GCA § 4401(d), the Chief Justice may reappoint a sitting magistrate without confirmation by *I Liheslaturan Guahan* upon a unanimous recommendation of the Judicial Council for an additional term of four years; and

WHEREAS, on February 21, 2022, I appointed the Magistrate Judge Evaluation Committee (the "Committee") chaired by Judge Alberto E. Tolentino and comprised of Jacqueline T. Terlaje (Guam Bar Association President), Danielle T. Rosete (Clerk of the Superior Court of Guam), Barbara Jean Perez (Human Resources Administrator of the Judiciary of Guam) and Andrew S. Quenga (Deputy Administrator of the Courts of the Judiciary of Guam) to evaluate the performance of Magistrate Judge Quan and to report its findings to the Judicial Council; and

WHEREAS, the Committee conducted a survey of Guam Bar members, court patrons, and court staff on the performance of the Magistrate Judge Quan, as well as a self-assessment by the magistrate himself; and

WHEREAS, Judge Tolentino presented a report on the results and findings of the surveys of Magistrate Judge Quan (the "Report") at the regularly scheduled Judicial Council meeting of June 16, 2022, and recommended the reappointment of Magistrate Judge Quan for another term at that Judicial Council meeting; and

WHEREAS, the Judicial Council considered the Report of the Committee and in Judicial Council Resolution No. JC22-016 unanimously recommended the reappointment of Magistrate Judge Quan for another term.

NOW, THEREFORE, by the authority vested in me by the aforementioned 7 GCA § 4401(d), I do ORDER, that sitting Magistrate Judge Jonathan R. Quan is hereby reappointed to serve an additional term as Magistrate Judge of the Superior Court of Guam together with all authority vested in such position by law. Magistrate Judge Quan's additional term shall commence on September 5, 2022, and expire on September 5, 2026.
