

PROCESS TO PROPOSE AN AMENDMENT TO A STATUTE

SUMMARY OF STEPS

- 1.) PRESENT THE CURRENT VERSION OF THE STATUTE.
- 2.) PRESENT THE PROPOSED AMENDED STATUTE.
- 3.) REASON FOR AMENDMENT. The Sub-Commission must indicate in writing the reason for the proposed amendment.
- 4.) REVIEW OF EXISTING CASE LAW. The Sub-Commission will review the following to ensure the proposed amendment does not conflict with existing, applicable case law.
 - (A) U.S. Supreme Court Case Law,
 - (B) Supreme Court of Guam Case Law,
 - (C) District Court Appellate Division Case Law and
 - (D) Superior Court of Guam Case Law.
- 5.) REVIEW OF STATUTORY SOURCE. If the information is available, the Sub-Commission should identify:
 - (A) What jurisdiction or state the statute being reviewed came from.
 - (B) What year Guam adopted the statute.
 - (C) If the originating jurisdiction or state still uses the original statute (if it is still “on their books”).
 - (D) If the statute is no longer being used by the originating jurisdiction or state, then when was it amended or repealed.
 - (E) If the statute was amended by the originating jurisdiction or state, please provide the amended statute below, the citation and the date of amendment.
 - (F) If “UNABLE TO DETERMINE” the source of the Guam Statute, please so indicate.

6.) MODEL PENAL CODE REVIEW. The Sub-Commission will review the Model Penal Code for guidance.

7.) REVIEW OF RECENTLY REVISED HAWAII OR D.C. CRIMINAL CODES. The Sub-Commission will review recently revised Hawaii or D.C. (or other jurisdictions) criminal code for guidance.

8.) AFFECTED STATUTES. The Sub-Commission will identify other Guam statutes, if any, that may be impacted by the proposed amendment.

9.) PROPOSED STATUTORY AMENDMENT TO BE SUBMITTED TO THE PLENARY COMMISSION. If the Sub-Commission reaches consensus that the proposed amendment be forwarded to the Plenary Commission for consideration, the Sub-Commission Chair must indicate so and sign and date the Worksheet.
