

What is Law Day?

Law Day is a national day set aside to celebrate the rule of law. Law Day underscores how law and the legal process have contributed to the freedoms that we all share.

2014 Law Day Theme:

American Democracy and the Rule of Law: Why Every Vote Matters



To enter, students must write an essay addressing the following questions:

Franklin D. Roosevelt, the 32nd U.S. President, once said, "Nobody will ever deprive the American people of the right to vote except the American people themselves, and the only way they could do that is by not voting at all."

- 1. What does this quote mean to you?
- 2. Why is it important for every citizen to exercise his or her right to vote?
- 3. Why is it important to be aware of and informed about issues and candidates before you vote?

Contest Rules:

- Students from 6th-8th grade are eligible to participate.
- Essays must address the questions above.
- Essays must be no more than 750 words, typewritten, and double-spaced.
- Essays must be the student's original work.
