
**RELATIVE TO APPROVAL OF PROPOSED BUDGET FOR JUDICIARY'S 2006  
J.U.S.T.I.C.E. AWARDS EMPLOYEE RECOGNITION PROGRAM**

- WHEREAS,** Justice Robert J. Torres and Judge Elizabeth Barrett-Anderson have undertaken co-chairperson roles in overseeing the Judiciary's 2006 J.U.S.T.I.C.E. Awards Employee Recognition Program committee, together with several employees of the Judiciary who have graciously devoted their time to assist with the Program; and
- WHEREAS,** the committee has devoted significant time to organizing the Program as cost-effectively as possible; and
- WHEREAS,** the committee recommends that plaques be presented to each of three Finalists in each of 14 separate categories and that a trophy be presented to the Winner in each category and, further, that plaques be presented to those with significant years of service with the Judiciary as well as to the employee with the best attendance record for the year, with such plaques and trophies having a total estimated budget of \$2,600.00; and
- WHEREAS,** the Judiciary's Employee's Association has agreed to allow the committee to present trophies to the award winners at the annual Christmas Gathering to be held at the Hyatt Hotel on December 1, 2006 with the understanding that the committee would make all reasonable efforts to secure the approval of the Judicial Council for a contribution of \$8,000.00 to the Association to help defray the expense of the event; and
- WHEREAS,** the committee is also planning a short ceremony, with refreshments, to be held on November 21, 2006 in the Judicial Center's Atrium at an estimated cost of \$400.00 so that the three Finalists in each of the award categories can be announced in advance of the Christmas Gathering; and
- WHEREAS,** the committee anticipates minimal additional expenses for incidental matters related to the Program; and
- WHEREAS,** a total budget for the Program is in the estimated amount of \$11,000.00 as itemized in Exhibit A hereto which is incorporated herein by this reference;


