RESOLUTION NO. JC12-002**

**RELATIVE TO COMMENDING THE HONORABLE ELIZABETH BARRETT-ANDERSON
FOR HER SERVICE TO THE GOVERNMENT AND JUDICIARY OF GUAM**

- WHEREAS,** Judge Elizabeth Barrett-Anderson contributed 30 years and 11 months of exemplary service to the Government of Guam, of which 15 years, 2 months and 24 days were service provided to the Judiciary of Guam; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson is a 1971 graduate of the Academy of Our Lady of Guam; earned a Bachelor's degree in Political Science from the University of San Francisco in 1974; and attained a Juris Doctorate degree from the University of Santa Clara School of Law in 1979; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson began her judicial service as a Clerk, July 30 - August 24, 1973; Clerk, June 4-August 23, 1974; Law Clerk, March 2, 1980 – February 27, 1981; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson continued her government career as Assistant Legal Counsel to the Department of Education on December 2, 1979 – February 29, 1980, and from March 2-September 30, 1981; Legal Counsel to the Department of Education on October 1, 1981 – December 14, 1984; Chief Deputy Attorney General, Office of the Attorney General, on March 23-July 6, 1987; Attorney General of Guam, July 7, 1987-July 4, 1994; as Senator, 23rd Guam Legislature, January 3, 1995 – January 3, 1997; and as Senator, 24th Guam Legislature, January 6, 1997 – March 25, 1998; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson served as a member of the National Association of Attorneys General, 1987-1994; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson was appointed as Judge to the Superior Court of Guam on April 14, 1998 and served through March 30, 2012; and
- WHEREAS,** in the past fifteen (15) years, she has diligently and professionally fulfilled her responsibilities as Judge by adjudicating cases, developing or improving standardized procedures for effective and efficient case management practices; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson is a graduate of the Basic and Advanced Leadership Institute in Judicial Education, Memphis, TN, December 13-15, 2000, and June 21-24, 2001, respectively; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson planned and implemented the first therapeutic Court in Guam, Juvenile Drug Court, in 2001; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson presented One Judge, One Family before the Enhancing Judicial Skills in Domestic Violence Cases training forum, June 28-30, 2001 in Boston, MA; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson's article entitled One Judge, One Family: A Problem Solving Court in Action was published in Today Journal, National Council on Juvenile and Family Court Judges, Fall 2003; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson has attended judicial training courses and conferences in furtherance of her dedication to the administration of justice, including substance abuse awareness, juvenile and family law, juvenile drug court, domestic violence, custody and visitation, restorative justice, evidence, juvenile and family court judges faculty development training, judicial philosophy and American law, sexual assault and stalking, judicial disqualification, science and technology, probate, and alternative dispute resolution; and
- WHEREAS,** Judge Elizabeth Barrett-Anderson served on the Board of Directors, National Association of Drug Court Professionals, from 2005 to 2007; and

WHEREAS, Judge Elizabeth Barrett-Anderson served as co-Project Director alongside Judge Anita A. Sukola, who were responsible for publishing The Guam Domestic Violence Benchbook, Order of Protection, A Guide for Judges, November 2006; and

WHEREAS, Judge Elizabeth Barrett-Anderson served as a Presidential Appointee to the Federal Advisory Council on Juvenile Justice, Office of Juvenile Justice and Delinquency Prevention, 2006-2008, under President George W. Bush; and

WHEREAS, Judge Elizabeth Barrett-Anderson served on the Asia Pacific Judicial Reform Forum, January 19-21, 2009, Singapore; and

WHEREAS, Judge Elizabeth Barrett-Anderson planned and implemented DWI Court in 2010 to the present; and

WHEREAS, Judge Elizabeth Barrett-Anderson has been nationally and locally recognized for the following awards and honors: 1979 American Jurisprudence Award (AmJur), for Remedies; 1993 Director of the Year, Government of Guam; 1994 National Notary Association Achievement Award; and 1998 Outstanding Woman of the Year, Guam Bureau of Women's Affairs; and

WHEREAS, Judge Elizabeth Barrett-Anderson is hereby retiring from the Judiciary of Guam and government service on March 30, 2012; and

NOW, THEREFORE, BE IT RESOLVED, that the Judicial Council of Guam hereby recognizes and commends Judge Elizabeth Barrett-Anderson for her leadership and dedication toward the improvement of the administration of justice in Guam, and thanks **Judge Barrett-Anderson for her service as a Judicial Officer.**
