

CHAPTER 3
BOARD OF CONTROL FOR VOCATIONAL REHABILITATION

NOTE: Rule-making authority cited for Board of Control for Vocational Rehabilitation, 17 GCA Chapter 41.

For rules and regulations adopted by the Board of Control for Vocational Rehabilitation, see separate publication by the Department of Vocational Rehabilitation entitled Board of Control Policy Handbook, adopted January 22, 1979, as amended from time to time.

As of June 1993, no further rules have been filed with the Legislative Secretary and, hence, the Compiler of Laws. However, there has been much restructuring and privatizing of vocational rehabilitation services. Goodwill Industries, Inc., a private, non-profit corporation, has taken over the operation of the Vocational Rehabilitation Workshop in Harmon.

§4100. Availability for Use. The Nieves M. Flores Memorial Library (Guam Public Library) is available for use by all persons living on Guam.

§4101. Application to Borrow Books. Residents of Guam wishing to borrow books from the Library shall file an application form giving names, P.O. address and telephone number. All borrowers are subject to the rules and regulations of the Libraries.

§4102. Child Memberships. Children first grade and up are eligible to register provided their parents authorize their membership.

§4103. Limitation on Number of Items Borrowed. Registered patrons may withdraw six (6) books, adults and parents four (4) records and three (3) filmstrips at one time. Any deviation will be at the discretion of the Librarian, whose decision will be considered final.

§4104. Lending Period and Renewal. The lending period has been established at fourteen (14) calendar days. At the end of the fourteen (14) days, the book or books and records may be renewed for an additional fourteen (14) days. For new books in great demand, a renewal period will not be granted.

§4105. Reciprocal Privileges - Other Libraries.

Public libraries shall maintain reciprocal borrowers' privileges, so that any person on Guam who is a member one (1) library may borrow materials from any Public Library.

§4106. Inter-Library Loan.

Inter-library loan will be practiced between libraries on the Island. Libraries desiring the material will be responsible to collect and return the material.

§4107. Fines.

A fine of Two Cents (\$0.02) per day, per book and Twenty-Five Cents (\$0.25) fine per day for reserve books including Sundays and Holidays will be charged for overdue books.

§4108. Reference Books.

Reference and Guam books and materials are for reference only, and may not be taken from the library at any time. The librarian is authorized to enforce this rule without exception. Reference and Guam books and materials will be plainly marked and so designated.

§4109. Replacement - Lost or Damaged Books.

Lost or damaged books must be paid for or replaced. The privilege of borrowing books will be suspended until the book is found, paid for or replaced. Charges for damage to books will be in proportion to damage sustained. Charges for lost books shall be set by the librarian and shall be based on the original cost of book and cost of replacement.

§4110. Hours.

(a) The hours for public libraries in Agat, Barrigada, Dededo and Merizo are Monday through Friday - 11:00 a.m. to 8:00 p.m. and Saturday - 10:00 a.m. to 4:00 p.m.

(b) The hours for the public library in Agana are Monday through Friday - 10:30 a.m. to 8:30 p.m. and Saturday - 10:00 a.m. to 4:00 p.m.

§4111. Librarian Authority - Final Decisions.

Full authority is hereby granted the librarian to make final decisions in case of any question pertaining to the borrowing of books, or enforcing the rules and regulations of the library.

CHAPTER 5

GUAM MUSEUM
